At Muskogee Golf Club, we have designed a variety of membership programs to suit your needs. The following is a summary of membership dues, fees and benefits for the Club.

### Golf Membership:

- This is a Family Membership offering full use of the Perry Maxwell 18 hole Championship Golf Course and all Club facilities
  - Spouse
  - Dependent children under the age of 23 and a fulltime student
- Membership fees include, cart and range balls
- Accompanied guest privileges
- Access to all Club sponsored events (must meet age requirements)
- Ability to host private business and personal events at the Club
- Tee time reservations are available
- 1 – year Membership agreement is required
- Monthly Dues:           \$347
- Initiation Fee:           \$400 (waived with 2-year agreement)

### Non-Resident Membership:

- Available to those individuals residing outside a 25 mile radius established by the Club offering full use of the Perry Maxwell 18 hole Championship Golf Course and all Club facilities
  - Spouse
  - Dependent children under the age of 23 and a fulltime student
- Membership fees include, cart and range balls
- Accompanied guest privileges
- Access to all Club sponsored events (must meet age requirements)
- Ability to host private business and personal events at the Club
- Tee time reservations are available

- 1 – year Membership agreement is required
- Monthly Dues: \$214
- Initiation Fee: \$100

### **National Membership:**

- Available to those individuals whose primary residence is outside a 50 mile radius established by the Club offering full use of the Perry Maxwell 18 hole Championship Golf Course and all Club facilities
  - Spouse
  - Dependent children under the age of 23 and a fulltime student
- Membership fees include, golf, cart and range balls for a limited 12 rounds per year
- Accompanied guest and cart rates will apply after 12 rounds
- Accompanied guest privileges
- Access to all Club sponsored events (must meet age requirements)
- Ability to host private business and personal events at the Club
- Tee time reservations are available
- Annual Dues: \$841
- Initiation Fee: \$100

### **Junior Membership:**

- Available to members ages 16 to 34 (Ages 16 – 21 are for individual memberships only)
  - Spouse
  - Dependent children
- Upgrade fee is due upon conversion to Golf Membership on the member’s 35<sup>th</sup> birthday
- Full use of the Perry Maxwell 18 hole Championship Golf Course and all Club facilities
- Membership fees include, cart rental and range balls
- Accompanied guest privileges
- Access to all Club sponsored events (must meet age requirements)
- Ability to host private business and personal events at the Club
- Tee time reservations are available
- 1 – year Membership agreement is required
- Monthly Dues: \$163 - \$315 based on sliding age scale (See below)
- Initiation Fee: \$100

### **Senior Membership:**

- Available to members who have reached their 65<sup>th</sup> birthday
  - Spouse
- Full use of the Perry Maxwell 18 hole Championship Golf Course and all Club facilities
- Membership fees include, cart rental and range balls
- Accompanied guest privileges
- Access to all Club sponsored events
- Ability to host private business and personal events at the Club

- Tee time reservations are available
- 1 – year Membership agreement is required
- Monthly Dues: \$291
- Initiation Fee: \$100

### **Social Membership:**

- Full use of Maxwell’s dining and the Pub
- All non-golf social functions
- Limited access to Golf Course
  - Total of six rounds in a calendar year. Must pay regular guest/cart fees
- Full use of driving range and practice green
- Ability to host private business and personal events at the Club
- 1 – year Membership agreement is required
- Monthly Dues: \$51
- Initiation Fee: \$100

### **Social Youth Membership:**

- Intended for children of Social Members who are involved in their school’s golf team or, who otherwise involved with golf at a competitive level.
- Parents have the same privileges as the Social Membership
- Children of the Social Member who are between the ages of 12 and “High School Graduate” may use the golf facilities. All golf fees shall apply. (Carts are not included)
- Any child under the age of 16 must be accompanied by a parent for cart rental
- 1 – year Membership agreement is required
- Monthly Dues: \$137
- Initiation Fee: \$100

### **Summer Youth Golf Membership:**

This is a seasonal membership (June 1, until August 31) intended for the competitive High School or College golfer needing to maintain his/her competitive edge during the summer months.

- Fee includes the full use of the Perry Maxwell 18 hole championship course after 1pm on Sunday, Tuesday, Wednesday, Thursday and Friday.
- Practice facilities are open every day (weather permitting) except Monday.
- Fee does not include Saturday or Monday golf, access to motorized golf cars, guest privileges, tee time reservations and/or any club sponsored event.
- Summer Dues: \$325 plus tax, total due upon acceptance w/cart \$428 plus tax

### **Corporate Membership:**

- This is a Company Membership offering full use of the Perry Maxwell 18 hole Championship Golf Course and all Club facilities
- Up to 4 Golf Memberships include:
  - Spouse
  - Dependent children under the age of 23 and a fulltime student
- Membership fees include, cart and range balls

- Accompanied guest privileges
- Access to all Club sponsored events (must meet age requirements)
- Ability to host private business and personal events at the Club
- Tee time reservations are available
- Golf Memberships (up to four)
- 1 – year Membership agreement is required
- Monthly Dues: \$1,119
- Initiation Fee: \$1,500 (waived with 2-year agreement)
- Any additional memberships that are added to the membership are \$250 plus tax, each
- The Corporation agrees to pay any, and all fees and charges for this membership

### **Corporate 6 Membership (aka VA, MPS, or City Membership):**

- This is a Family Membership offering full use of the Perry Maxwell 18 hole Championship Golf Course and all Club facilities
  - Spouse
  - Dependent children under the age of 23 and a fulltime student
- Membership fees include, cart and range balls
- Accompanied guest privileges
- Access to all Club sponsored events (must meet age requirements)
- Ability to host private business and personal events at the Club
- Tee time reservations are available
- 1 – year Membership agreement is required
- Monthly Dues: \$217
- Initiation Fee: \$100
